All Saints' Day & All Souls' Day

Today, November 1, is All Saints' Day. Tomorrow, Monday, November 2nd, we will celebrate All Souls' Day. I will celebrate the 8:15 a.m. Mass, the school Mass, a Noon Mass, and, consistent with the tradition that we established last year, the evening Mass at 6:30 p.m. will be a Memorial Mass for all the parishioners who have died within the last year. (Please note that November 2 is not a Holy Day of Obligation, but it is a day that the Church invites us to take seriously as we help our beloved dead become purified and so able to see God face to face.)

Prayer Vigil for Election

You are invited to pray in the presence of the Lord, beginning after the 6:30 p.m. All Souls' Day Mass on November 2nd through the evening until 8:00 p.m. on Tuesday, November 3rd. You can sign up for an hour of prayer on our website. We will have adoration/exposition through the night. As we anticipate this election, let us all be prayerful for the nation, that the Common Good might truly be advanced and the most vulnerable might be protected. This election, as you know, is very consequential in this very challenging, politically divided time. As I mentioned last week, as we pray about the election, let us always add "not my will, but yours be done," since God's will, whatever that might be, is where we are invited to have true peace.

Update on Legal Complaint Filed

A few weeks ago, I emailed to ask everyone to pray for the leaders of the Church and government after Governor Whitmer issued Executive Order 185, which was scheduled to go into effect on October 5. It required, among other things, that K-5 students wear masks in the classroom. On Friday, October 2, the Michigan Supreme Court called into question all of the Executive Orders that Governor Whitmer had issued after April 30, including E.O. 185. The Supreme Court's ruling prevented it from going into effect. We were disappointed but not surprised that the Michigan Department of Health and Human Services issued an order that mirrored the contents of E.O. 185 on October 5th.

Since that time, we have prayed and consulted with Counsel on the prudence of challenging the actions of MDHHS and Ingham County Health Department, which followed the Supreme Court's decision. Based on concerns expressed by several families about the effects of this change, we explored our options. As we contemplated filing a Complaint, we benefited greatly from the work of the Great Lakes Justice Center and the American Freedom Law Center, along with Diocesan Counsel. We asked Bishop Boyea's permission to pursue this action, which he granted. These lawyers worked with other Plaintiffs and us to craft the Complaint which challenges the legality of the actions of MDHHS and the Ingham County Health Department regarding mandatory masking.

The Complaint was filed on October 22, the Feast Day of Pope St. John Paul II, in Western District Court of Michigan. Please pray for a just outcome of the legal proceedings.

Explaining Our Actions

Jacob Allstott, Resurrection School principal, and I sent a letter to parents in the school this past Tuesday, which explains the rationale for this legal action and summarizes our concerns. You can find it on our website. Some might be tempted to allege that we are unnecessarily politicizing this, but I assure you all that we are reluctant litigators. Our concern remains the wellbeing of students in every aspect of their persons. The actions of the State and County, we believe, overreached their proper authority and have harmful consequences for our students and their families. We are most concerned about the least of these in our community, and hope and pray for a just outcome of this legal action.



2021 GUIDELINES FOR SCHEDULING MASS INTEN-TIONS

POLICY & PROCEDURE

- Mass stipends are \$10 and are to be paid when requesting Masses. Payable by check or exact change only.
- Limit of 6 Masses per parish family may be requested for the year, (up to 2 of these can be for the Sunday obligation)
- Only 1 intention per Mass is allowed, per Canon Law. However, to better accommodate the needs of our parishioners, we can list up to 2 first names with the same last name (i.e. John & Mary Smith) OR 2 last names (i.e. Jones & Smith Families)
- No Mass will be permanently affixed in the Mass Book until the stipend is received.

° The first stipend received is assigned the date.

SPECIAL NOTES TO REMEMBER

- One Sunday Mass per weekend is offered for the intention of the Parishioners of Resurrection
- Have an alternate date/time in mind
- Please note that scheduled Masses may need to be moved to another date/time due to the availability of our priest.
- All Mass intentions over 6 requests will be sent to a Mission assigned by the Diocese.

The 2021 Mass Book will be open November 2, 2020.
