Update on the Mask-Mandate Lawsuit

I sent this message out in an email on Tuesday, but wanted everyone to have access to it, so I'm reprinting it here: *Surely some of you have recently read (or seen) news describing the appeal to the Sixth District Court of the decision in our lawsuit that was filed last October. News reports have drawn a lot from our original filing, including what was admittedly an unfortunate exaggerated claim that Catholics believe that "masks hide the image of God." We do not believe that, as you well know. The fact is, we have recommended mask wearing in Church and required them for older students and teachers in our school. Our Amended Complaint, dated December 9, 2020, includes the following language about the place of masks and the challenges we wanted to address as we sought to most effectively foster spiritual, academic, and social growth among students in our classrooms:*

24. . . . Resurrection School is a Catholic school that has adopted a curriculum and disciplinary policies that honor the dignity of every student, and it provides an education based upon the teachings of the Catholic faith.

25. In accordance with the teachings of the Catholic faith, Resurrection School believes that every human has dignity and is made in God's image and likeness. As the Catholic faith teaches, humans are relational beings called to love God and neighbor. By fulfilling the two greatest commandments to love God and our neighbor, Catholics, like all Christians, hope one day to see God face to face. Here on earth, where they learn to love and prepare to see God, Catholics are called to love others as themselves, and to see Christ in the "least of these." Seeing others in their need and condition helps us know what love demands. Jesus made seeing the other a priority. When talking with the Pharisees, Jesus asked them in Luke 7, "Do you see this woman . . ." For Jesus, and for us, seeing the other in his or her wholeness and his or her need helps us know how best to give and receive love as God loves. In this, our human experience is patterned after the Holy Trinity—the Father, the Son, and the Holy Spirit—who eternally give and receive love. Looking at a person's face or their countenance helps us see and understand them. The face is the way we best recognize others. It reveals the distinctiveness of our person and personality. Facial expressions convey thoughts and emotions such as joy, fear, hopes, anxiety. Facial expressions also provide cues to levels of disengagement or engagement.

26. Wearing masks makes it significantly more difficult to see the countenance of others, to detect their emotions, their engagement, interest, puzzlement and/or concerns. Masks also make it more difficult to hear voices, which is another fundamental way that intellectual, emotional and/or spiritual concerns are expressed. As such, masks are disruptive of the essential, relational aspects of human intercourse. They make it more difficult to "see" and "hear" the other in his or her emotional and affective state. In these ways, masks make it more difficult to freely and effectively see, know, and love others. Plaintiffs share these deeply held religious beliefs.

The reason we filed the original lawsuit was our concerns about the effects the mandate would have on the "least of these" in our school. Students did, in fact, struggle to tolerate the masks, and others had difficulty communicating or understanding the nuances of facial expressions, etc. We desired last October, and continue to desire, to have our teachers and staff interact with students (and the students with each other) as we had planned prior to last school year. As you may know, Resurrection School was successfully open all year for in-person instruction. We had a good year, and we hope to have a good year next year. We made the right choice, I believe, and the families who partner with us are grateful for our

actions. We were pleasantly surprised that our percentage of attendance was higher than the year before, and we rejoice that student academic growth was off the charts, thanks to the hard work of our teachers and administrators and the cooperation of our families.

Because we have reasonable concerns that mask mandates could be reissued (as rumor has it, for those as young as two years old!) at any time, we decided to appeal the ruling to the Sixth District Court.

As you might expect, the recent publicity has renewed ridicule we received from media outlets, social media, and by phone. And though I regret the exaggeration in the original filing made about masks "hiding the image of God," masks do in fact make it more difficult for us to form students as disciples of Christ and citizens of our nation. As all the parents of the school know, we made great preparations and plans prior to the school year, including our commitment not to require K-5 students to wear masks, and the parents agreed to our plan.

When the K-5 mask mandate was established in October of 2020, as educators, we chose to stand against what we deemed—educationally, medically, and socially—to be an unnecessary and unjust mandate. Parents had agreed to the provisions we had in place at the beginning of the year, and we sought to follow through on that agreement out of concern for what we and they discerned was comprehensively best for their children.

Though I was among those who were very concerned at the start of COVID, it became clear over time that public policy decisions were ordered to honoring one supreme value, virus prevention, and seemed in many cases to ignore other values that are vital to the common good of the community and members thereof. We believed (and believe) that values in addition to virus suppression should have been taken more seriously in the public policy calculus.

Years from now, I suppose, we, along with everyone in the world, will know the effects of all of these public policy actions along with the as yet unknown unintended negative consequences thereof.

I grieve that we felt forced to file this lawsuit, but am more grieved that public policymakers overreached by establishing the K-5 mandate, which is what helped us discern that challenging the mandate in court was warranted. I pray that the mandate does not get reestablished, but we are continuing the lawsuit because we hope to get a favorable ruling.

As always, I am happy to speak with any of you about our actions in this regard. Other pastors have chosen different prudential paths. As pastor of this parish and school, after taking counsel with others, I decided that we would proceed with this lawsuit. Today, despite the pushback, our conscience remains clear. I believe that we are doing what is in the comprehensive best interests of our students and their families.


If you would, please pray for the appeals court judges, all leaders, and for us, for wisdom and clarity.
